There was no change in the number of Issuer shares held by KKR Phorm Investors L.P., but KKR Group Partnership L.P. and certain other affiliated reporting persons may be deemed to have disposed of a portion of their pecuniary interest in the Issuer shares as a result of the transfer. The closing price of the Issuer's shares on September 30, 2020 was \$4.70 per share.

Inc. is the sole shareholder of KKR Group Holdings Corp., KKR Management LLP is the Series I preferred stockholder of KKR & Co. Inc., and Messrs. Henry R. Kravis and George R. Roberts are the founding partners of KKR Management LLP.
